As of 18 March 2025, individual comments will no longer be published on the Council's Public Access system.

This is because there have been instances of personal data and information being shared and we have a duty to protect the personal information of individuals under GDPR rules.

People will still be able to put forward their views on any planning application they are eligible to comment on – and these views will be fully considered when determining the application, as has always been the case.

The time available to enter comments in Public Access expires quite quickly. To avoid losing long comments, consider typing them in a separate document (such as Word or NotePad) and then copying and pasting them into the comments page.

Attend LMPC Planning Meeting.

The usual venue for a Parish Planning Meetings is:

Rosetti Hall, New Pond Road, Holmer Green, Bucks HP15 6SU. (Please check as they can also be held within different wards).

Public Participation: Whilst these meetings are a public forum, please note that the right to speak on any matter is reserved for a specific period at the commencement of the meeting. This is the public participation section.

If you wish to speak during this time about an item, please be aware of the following:

- **Matters of Concern:** You can raise matters of concern or items for discussion pertinent to the agenda.
- **No Immediate Response:** A question asked during this section will not require a response at the meeting, nor will it start a debate. The Chairperson may direct that a written or oral response is given later, or that the item is added to a future agenda as appropriate.
- **Pre-registration Required:** Should you wish to speak during public participation, you must pre-register with the Clerk by 9:00 AM on the Friday prior to the meeting to reserve your 3-minute slot.
- **Time Limit:** Please note that there is a maximum of 15 minutes overall for this section, and slots are allocated on a first-come, first-served basis.
